D. Regular Business

- a. Program Change: [RPS 868: Rehabilitation Psychology](#) (*curricular changes*)

Kelley presented program changes to the Committee. Changes include minor edits to Guide content, LAS designation changes and the addition of a course added as an elective option. The four year plan was also updated. Gerloff clarified that the changes to the four year plan would be reflected in the Guide. Gerloff showed the Committee an example that listed four potential four year plans students could follow. She said the potential plans demonstrate to students that they can be creative in their course selection. Gerloff stated that the four year plans need to be approved through governance. She also expressed some concerns that students will not understand the samples as moveable examples that will vary depending on that particular individual's situation. Approved.

- b. Course Change: [KINES 370: Planning, Facilitating & Assessment in Movement and Health Professionals](#) (*LAS designation and breadth, requisite change*)

This course is adding an LAS designation and changing the breadth and requisites requirements. Kelley said that the current requisite, "declared in physical education," should be removed because this course is part of the new HPHE major and HPHE students will also need access to the course. The Committee had a discussion about the differences between requisites and enrollment information. Campus governance has determined that anything listed as a requisite should be enforceable. Any suggested or recommended coursework should be listed under enrollment information, as it serves as a suggestion to interested students. The Committee recommended that the current requisite be removed, as it looks like it should be listed under enrollment information. The course is approved pending the removal of the requisite. Approved.
